3.1 Staffing

Sub situation is going to cause us problems

One teacher will be out for 2 weeks with no sub

Another teacher will be out for maternity leave SOSA should be able to provide coverage Another teacher will come back from a leave around the 24th

### 3.2 Math Intervention

Rodney brought some parent concerns another parent had shared with him about the intervention. Felt it hadn't been communicated thoroughly, confused about why we were starting earlier, what the process and purpose was for this earlier start time.

Dr. Sabo shared concerns about parents not sending their kids during the earlier time if they knew it was voluntary

A concern about using "intervention" in the title could be a turn off for some families. Parent suggested What I Need (WIN)

Questions brought up:

- Subs (their start time is 8:30 but now they get no preparation time) will we burn out subs because of it Subs are not required to participate. Floating staff members will cover that class
- Staff members being burnt out earlier due to the extra responsibilities Dr. Sabo is mindful of that. Teachers have come to him with concerns about feeling overwhelmed with all the new things (Phonics, Reading, Math group time). He also has to keep in mind that our scores are low and we need to move things into a higher gear to begin trying to catch them up.
- Are we tracking to see the benefit of the math group time? Grade level meetings will be held every 6 weeks to track student progress (following the reading group format). MAP will be utilized and another monthly test will be given to try to track student progress
- Is there someone who teachers can share their frustrations and concerns with that can be shared with administration anonymously? Both Amanda Benavidez and Carrie Bowden are willing to share teacher concerns with administration.

## 3.3 Attendance

Still seeing a high number of students absent every day. Some are due to sickness.

Attendance person has been going out with Dr. Sabo to visit homes (he is showing how to interact with the families). Absent students this year are checked against last years chronic absenteeism and they receive a visit. Students marked yellow (not excessively high absences last year) receive a phone call.
